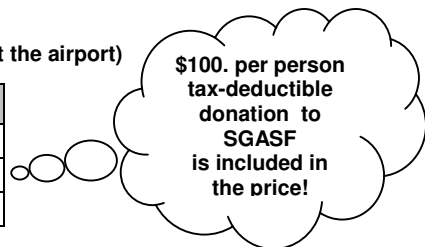

Cancellation Policy:

Space cancelled after final payment will be subject to the cancellation penalties listed below:

- 90 days or more prior to departure - \$100.00 per person
- 89 - 30 days prior to departure - \$550.00 per person
- 29 - 15 days prior to sailing - 50% of total price
- 14 or less days prior to sailing - **NO REFUND**
